OFFER OF A QUAIL HUNT IN ROMANIA

Place:

Hunting grounds around Oradea and Arad (Hungarian - Romanian border). These are field grounds, where in the case of ideal weather conditions there is a huge number of quails and turtle doves or ring pigeons, which can also be hunted for. Under optimal circumstances, the average shooter has no problem catching 30 or 40 quails in one day, or 50 or more pigeons.

<u>Time:</u>

• August 15 – September 15 (the last two August weeks or the first September week are optimal)

Methods of hunting:

- quail common hunt rough shooting,
- turtle doves and pigeons pass shooting (mostly in sunflowers).
- Optimal is the 5-6-member composition of the hunting group (if necessary, we will add the individual hunters to the given group of hunters).
- We recommend using ammunition 2.00 2.50 mm for quail hunting, 2.50 3.00 mm for turtle doves.

Program of the hunting event:

Day 1 – arrival at the place of accommodation, lunch, rest, evening quail hunt in the grounds, dinner,

Day 2 - morning quail hunt, breakfast, rest, lunch, free program, dinner, evening hunt for pigeons and turtledoves,

Day 3 – morning quail hunt, breakfast, rest, end of the hunting event

Price list of the shooting:

• Flat rate – EUR 400 /stay, the fee includes 5 walks in the grounds, securing dogs (for 2 hunters one quality setter), catching an unlimited number of quails, pigeons and turtledoves, accommodation (each hunter has a separate room) with a rich full board.



Accompanying fees:

- Fee for issuing the hunting license (including statutory insurance) EUR 50 /person,
- Organizational fee EUR 210 /stay/hunting group. This fee applies to the whole hunting group and not to the individual (divided according to the number of members of the hunting group) and includes the personal participation of our representative from the arrival of the hunting guests until their departure (including the services of an interpreter). If you do not request the personal participation of our representative, this fee will not be charged.
